#### Rules and Regulations for Hunting at the Aberdeen Property

The Town owns 198 acres of land that is located at: 16385 Short Hill Road. This property is for the Town's future water supply and is under a restrictive deed. Do to the proximity of residential homes, only bow hunting is allowed. Compliance with the Virginia Game and Department Regulations Manual is mandatory. Hunting would be allowed only during Archery Season and prohibited any other time of the year. Hunters must stay in the boundaries of the property and must stay 100 feet off of the property lines which will be marked with No Trespassing Signs and marked with White Paint.

Hunting is a Privilege that is granted by the Town with Strict Adherence to the following Rules and Regulations. Once Rules and Regulations are broken privilege to hunt is suspended.

- No more than 4 hunters are allowed to hunt on property at one time.
- Must have a Virginia Hunting License. A copy of the Hunting License will be given to the Public Works staff to have on file.
- Must sign a Hold Harmless Agreement/Release of Liability against the Town from any injury or accident that may occur while hunting on Aberdeen Property.
- Before entering Property at 16385 Short Hill Road you must sign at gate (locked mail box)
  - a. Name.
  - b. Date and Time.
  - c. Cell phone number and email
  - d. Location of Hunt (Zones 1,2,3,4).
  - e. When Leaving Sign out and Time.
- Parking is available at the barns on the property.
- BOW HUNTING ONLY.
- Must bring your own tree stand and Hunt from tree stand at all times. Town Staff will give out tags to have installed on tree stands for identification.
- Access to the property will be 1 hour before sunrise until 1 hour after sunset. The only exception will be if you were recovering an animal.
- No fires or camping will be permitted on the property. No smoking of any material will be permitted on the Town property.
- Use of Mobil phone Apps like "Hunt Stand" and Avanza map application.
- All trash and litter must be removed from premises.

Primary goal is to reduce the deer population due to environmental, health and safety impacts.

The Town is not required to give any warning of hazardous conditions on, uses of structures on, or activities on such land or premises, unless such condition, use, structure or activity is the result of the Town's gross negligence.
