A RESOLUTION: RESOLUTION EXTENDING THE TERM OF THE COMCAST OF

CALIFORNIA/MARYLAND/PENNSYLVANIA/VIRGINIA/WEST

VIRGINIA, LLC, CABLE FRANCHISE AGREEMENT

WHEREAS, effective on September 1, 2007, the Town Council (the "Council") of the Town of Purcellville (the "Town"), and Comcast of California/Maryland/Pennsylvania/Virginia/West Virginia, LLC ("Comcast") entered into a Cable Franchise Agreement (the "Franchise"); and

WHEREAS, the Franchise expires on August 31, 2022; and

WHEREAS, Town staff and Comcast have initiated discussions concerning the renewal of the Franchise; and

WHEREAS, Town staff and Comcast anticipate that because of the complexity of the issues involved in the renewal negotiations those negotiations are unlikely to be completed before the expiration date of the Franchise; and

WHEREAS, the Council wishes to extend the term of the Franchise to allow time for the parties to complete negotiations; and

WHEREAS, by letter from Comcast's Director of Government and Regulatory Affairs to the Town Manager dated July 19, 2022, a copy of which is attached to this Resolution, Comcast has provided its consent to the proposed extension of the Franchise; and

WHEREAS, the Council and Comcast both desire to reserve their respective rights under state and federal law, including, without limitation, 47 U.S.C. § 546.

NOW, THEREFORE, BE IT RESOLVED THAT the term of the Franchise is hereby extended from August 31, 2022, until January 31, 2023.

This Resolution shall be effective immediately upon adoption.
