Jessica Keller, PE, Capital Projects Coordinator, gave the report.

Council member Stinnette moved that the Town Council approve staff to move forward the Loudoun County grant funding request for \$613,580 for the S. 32nd Street Sidewalk, and approve the attached Resolution Number 22-09-01, and authorize the Town Manager to execute said application for funds and to execute all project administration agreements for any approved projects.

### d. Budget Appropriation to Expand the Scope to Replace Damaged Subfloor at Bush Tabernacle

Bob Dryden, Facilities Specialist, gave the report on the condition of fifty present of the floor at the Bush Tabernacle.

Council member Grewe moved the Town Council approve Budget Amendment BA 23-005 to transfer \$ 80,000, from the Parks and Recreation CIP Reserves Fund to the Bush Tabernacle Construction Fund in Fiscal Year 2023 to complete the Floor replacement and improvements to the Tabernacle.

Council member Stinnette made a friendly amendment to prioritize with this allocation of money (Mayor stated amount of \$10,000 or more) to remove all of the floor at one time and a no kidding assessment (end to end assessment of the remediation) of the condition underneath that floor with continued updates (on the project) to Town Council.

#### **DISCUSSION/INFORMATIONAL ITEM(S):**

#### a. Future Town Council Meetings and Agenda Topics

David Mekarski, Town Manager, gave the report.

Council member Stinnette reviewed public hearing Mayfair timeline regarding Planning Commission and when they would report to Town Council and suggested to Mr. Mekarski in sharing the tentative schedule with keeping in mind advertisement requirements for public hearings and Planning Commission meetings. Council member Grewe suggested that there would be an upcoming item regarding the Google Wifi to the next work session. Mr. Mekarski also shared the update of including on an agenda: the information from Tree and Environment Sustainability Committee re: Mr. Cable's request 12<sup>th</sup> St trees being removed and Code of Ethics from Vice Mayor Bertaut. Mayor Fraser also added a reschedule of the presentation from this evening and also the noted company wanting to do fibers to the homes.

#### b. Update on Hirst Farm Pond

Dale Lehnig, Director of Engineering, Planning and Development, gave a detailed report at the meeting. She shared information from after the update given in February 2022 to Town Council the engineer of record involved in the project was no longer a contracted group with the town. The project has been moved forward with Kimley-Horn and was accepted with a staff kick off meeting on August 31<sup>st</sup> along with the County. This project will need to be more collaborative

with the County than in the past. There is a tentative schedule of the first step to be a geotechnical borings on the dam and after receiving this report there will be a better idea of what is required for the design on the project. There will also be a review of the hydrological modeling of what was already researched for Kimley-Horn to confirm and place their stamp on the project. Staff expects final design plans and updated construction costs estimates to be reported in early 2023 and an update from Loudoun County regarding additional funding depending upon the costs and the per pound of phosphorous being removed. Mr. Mekarski added this project may fall under the Bipartisan Infrastructure Law under Storm water Management for additional federal funding. Mayor asked if this project is necessary to move forward with. Ms. Lehnig shared the project has been going on for several years and even though it was originally a wet pond it was intended to be a dry pond and with engineering firm assessments if it were to be turned into a wet pond, it would remove phosphorous and would give credits back to the County for their MS4. There is a liability issue with a safety concern on no ledges installed and the amount of silt in the pond. With the wet pond option there would be secured funding from Storm water local assistance funding \$300,000 and the County has offered \$150,000 towards the project. The bid would go out in early 2023 and the project be complete by the end of 2023. Remote citizen comments were heard on the project: David Dey, 716 Sturbridge Court, shared the HOA Hirst Farm has funding to deal with a resolution on this project and John Standley, 324 Spring Branch Court and President of HOA Hirst Farm, appreciates any effort for resolve of safety and beauty of the environment to move forward with this project and there is no HOA budget line for the pond itself. Vice Mayor Bertaut requested that before the geotechnical boring is done to have an advance notice. Mayor confirmed that there were stricter requirements from the County that has delayed the project. Ms. Lehnig shared that waivers submitted to the County have been denied and the structure is considered a dam by the County. Ms. Hankins, Town Attorney, needs to research this matter on regulations and challenge, if needed. Ms. Lehnig shared that the project for the additional engineering portion costs is short by approximately \$93,000 and there are no other estimates to share at this point. Another citizen comment by Casey Chapman, 205 Hirst Road, questioned Ms. Lehnig if it is permissible for the town to purchase credits to deal with this issue. Ms. Lehnig shared it is not applicable at this time to purchase credits and it was the HOA preference to have it be a wet pond. Council requested that Ms. Hankins revisit with the County Attorney office in regards to a reasonable argument to disagree in regards to the interpretation of an existing pond to possibly have them withdraw their opinion and report back to Town Council with a status.

## c. Wastewater Treatment Plant Emergency Incident Root Cause Analysis (RCA) and Solution Response

Jason Didawick, Director of Public Works, gave the report and referenced the staff report in the agenda packet. Vice Mayor Bertaut requested more information on the testing of the cabling post installation being done at regular intervals or will it be a one-time determination of the measurements. Mr. Didawick shared that the infrared scan testing, by steps through proper procurement, would need to be done now and again later possibly annually with also researching how other municipalities and the professional service proceed with this type of process. Council member Milan questioned if the same wiring configuration was used for the backup generator (diesel operated) and this was confirmed to be the same conduit because of high costs

to make a change. Also, Council member Milan questioned how is the testing be done and is there an online testing. Barry Defibaugh, Superintendent Public Works, shared that staff will be going forward with the testing recommendation from professionals on how often to test and the inspection of the cable would be added to the maintenance calendar.
