WHEREAS, Va. Code § 44-146.19 provides that each political subdivision within the

Commonwealth shall: (i) be within the jurisdiction of, and served by, the State Department of Emergency Management; (ii) be responsible for local disaster mitigation, preparedness, response and recovery; and (iii) have a Director of Emergency Management that is appointed by the Town

Council; and

WHEREAS, Va. Code § 44-146.19 further provides that the Director of Emergency

Management for each locality may, in collaboration with (i) other public and private agencies within the Commonwealth, or (ii) other states or localities within other states, develop or cause to be developed mutual aid arrangements for reciprocal assistance in case of a disaster too great to be

dealt with unassisted; and

WHEREAS, the Town does not have an emergency management organization that is

separate from that of Loudoun County, but requires the person acting as the Town's Director of Emergency Management to coordinate with Loudoun County on behalf of the Town, when the locality is under a state

of emergency; and

NOW, THEREFORE, BE IT RESOLVED that Town Manager is hereby confirmed to be the

Town's Director of Emergency Management, to perform all functions recited herein, and is authorized to designate someone to act in his stead

should be become unable to act.

BE IT FURTHER RESOLVED that the Town Manager is authorized and directed to exercise

all such powers, functions, and duties as allowed under State law, Town ordinances, Town resolutions and plans, deemed by him during a state of emergency to be needed in order to mitigate the effects of the emergency.
