THIS DEED OF ASSIGNMENT OF 10' TRAIL EASEMENT AND MAINTENANCE AGREEMENT is made the \_\_\_\_\_ day of \_\_\_\_\_\_, 2020, by and between the <u>KINGSBRIDGE MANOR HOMEOWNER ASSOCIATION</u>, a Virginia nonstock corporation ("Assignor"), <u>TOWN OF PURCELLVILLE, VIRGINIA</u>, a municipal corporation (hereinafter referred to as "Assignee").

#### WITNESSETH:

Whereas, on March 8, 1995, the Assignor acquired from G & M HOMES, L.C., a 10' Trail Easement within a portion of Lot 9, Kingsbridge Manor Subdivision (the "**Property**"), by Deed recorded at Deed Book 1358, at Page 113 and Plat recorded at Plat Cabinet B, Slot 181, Pages 7-10, among the land records of Loudoun County, Virginia; and

Whereas, the trail and appurtenant facilities located within the 10' Trail Easement provides, among other things, access to Loudoun Valley High School and is currently operated and maintained by the Assignor, and

Whereas, it is the desire and intent of the Assignor to transfer and assign unto the Assignee, the 10' Trail Easement in the locations as shown on the Plat; and

Whereas, it is the desire and intent of the Assignee to assume the 10' Trail Easement including, without limitation, all of the the maintenance, repair and upkeep obligations in connection therewith.

NOW THEREFORE, in consideration of the premises and sum of One Dollar (\$1.00), cash in hand paid, receipt of which is hereby acknowledged, the Assignor does hereby transfer and assign unto Assignee, its successors and assigns, all of its right, title and interest in the 10' Trail Easement. Assignee shall have full and free use of said easement and all rights and privileges reasonably necessary to the exercise of said easement.
